

## Annexure A Retainer Fees

#### <u>R3000 – R6000/month</u>

Accounting, Bookkeeping, Payroll, Tax and Compliance — R1–R5 million annual turnover 3-5 years retainer fees.

This is the monthly rate for accounting, bookkeeping, payroll, tax, and compliance services if your business has between R1 million and R5 millions in annual turnover. The price can vary depending on the size and complexity of the business. For an accounting monthly package — R1–R5 million annual turnover, expect to pay between R3000/month and R6000/month.

#### <u>R6000 - R12,000/month</u>

Accounting, Bookkeeping, Payroll, Tax and Compliance — over R5 million annual turnover 3-5 years retainer fees.

The cost of Accounting, Bookkeeping, Payroll, Tax and Compliance — over R5 million annual turnover typically runs from R6000/month to R12,000/month, averaging at R9000/month.

#### R12,000 - R24,000/month

Accounting, Bookkeeping, Payroll, Tax and Compliance — over R10 million annual turnover 3-5 years retainer fees.

The cost of Accounting, Bookkeeping, Payroll, Tax and Compliance — over R10 million annual turnover typically runs from R12,000/month to R24,000/month, averaging at R19,500/month.

## Annexure C Contingency Fees

Contingency fees are based on a percentage of the tax savings or refunds secured for a taxpayer or the reduction in the tax liability.
